FIRE REPORT

<u>Updates:</u> Chief Rospert informed all that the MTFD completed 10 runs in Oct, including aid in Margaretta which lasted 6+ hours. He also noted that 20 MSA air bottles that were ordered are in service. Chief Rospert and F.O. Rospert will be working together to complete the FEMA Grant for the 20 MSA air bottles, 12 MSA SCBA bottles, and 25 masks.

<u>Upcoming Events</u>: The MTFD will be assisting with the Holly Run on Saturday, November 14th, 2020.

<u>Lawrence "Smitty" Smith:</u> The MTFD along with other local fire departments will be conducting a full Fire Funeral in honor of Smitty, who worked for the Village of Milan for over 40 years, serving as street superintendent, zoning inspector, and as a member of the Milan Township Fire Department for 38 years.

MAINTENANCE

<u>GovDeals</u>: Mr. Hudson noted the crack sealing machine sold for \$4,550. All other items are on GovDeals and he plans to wait until spring to sell picnic tables.

<u>Completed & Upcoming Tasks</u>: Mr. Hudson informed all that the Town Square bathrooms have been painted, the sump pump under the Town Hall elevator has been replaced, and the Fire Departments were cleaned for Election Day. Upcoming tasks include closing Edison Park, fixing tracks on Town Hall wheelchair ramp, and completing a tool inventory at the Township building.

<u>Cell Tower Update:</u> Mr. Landoll informed all that former Z.I. Colleen Arthur had approved the cell tower on SR113 and McIntyre in 2019; therefore, the driveway permit was sent out this week as requested.

<u>CARES Act:</u> Mr. Frederick shared a quote provided by R.J. Beck to complete the installation of a door in the Town Hall and Fire Station; however, the Trustees agreed to continue with Accurate as the quote detail appeared sufficient and the quote was lower. Mr. Frederick then noted that while the elevator at the Town Hall was fixed, the phones are now not working. Frontier will be coming to check equipment. Mr. Frederick motioned and Mr. Shover seconded to allow R.J. Beck and/or Frontier to service a new phone line from the Frontier electrical box to the elevator equipment line, if needed. Motion passed unanimously.

<u>River & Berlin Rd. Intersection</u>: Mr. Frederick passed out all four drawing options provided by Tim Llyold, PE and Matt Rogers, PE from the Erie County Engineer's office for Trustees to review in order to determine next steps for the project.

<u>Bridge Project</u>: Due to a delay in receiving lumber for the Berlin bridge repair, the Trustees plan to order steel for the project in order to complete prior to the November 25th deadline.

Edison Ridge Lighting: F.O. Rospert will review emails and next steps to ensure the lighting project is completed with all new poles and lights at Edison Ridge.
